MAYOR

1. Mayor's report. For the month of December, the village received \$25.00 in fines from the Andover Mayor's Court.

ADMINISTRATOR

1. The administrator said there was no written report for December activity. The month was mainly spent conducting snow removal and fixing 6 significant water leaks at Holiday Camplands. He briefed the new councilmembers that his monthly report is not an inclusive report of all the work that is done in a month but a snapshot of the highlights.

CORRESPONDENCE. The mayor reviewed the following correspondence in addition to the items presented for council's review.

1. Meeting for school-based health center. Council received information about the community engagement session to be held on Monday, January 19 at 5:30 at the school auditorium to discuss the possibility of Ashtabula Regional Medical Center and Pymatuning Valley Local Schools developing a primary care health center on the school campus.

LEGISLATION. The mayor read the titles of the following legislation presented for council's consideration.

1. 2nd Reading, **Ordinance No. 2025-8-O**, an ordinance approving the Firefighting Agreement between The Village of Andover and The Andover Volunteer Fire Department, Inc. for a term of two (2) years commencing January 1, 2026 and ending December 31, 2027 and declaring an emergency. Councilmember Hornyak moved to accept the 2nd reading and move the ordinance to a 3rd reading. Councilmember Orahoad seconded the motion. Councilmember Hornyak; yes. Councilmember Orahoad; yes. 2. *Ambulance and Emergency Medical Services Agreement.* Councilmember Gentry advised tabling the proposed agreement until Chris Brooks of Community Care Ambulance Network (CCAN) could be present to discuss it. The group agreed that the agreement was not ready to be signed; they had some questions and would like to see changes made. Councilmember Limestoll will contact CCAN to discuss some of the concerns and to arrange a meeting.
3. Waive fee. The fiscal officer requested that the \$30 fee for outside users of the water & sewer utility be waived for Jeannette Hollis as she is seeking to annex her property to the village. Councilmember Limestoll moved to waive the fee. Councilmember Davis seconded the motion. Councilmember Limestoll; yes. Councilmember Davis; yes. Councilmember Orahood; yes. Councilmember Nipple; yes. 4. Joint meeting. The fiscal officer said the February council meeting will be a joint meeting with the township trustees to reappoint Dave Roberts and Bill French to the Andover Union Cemetery Board.
5. Open seat on the Planning Commission. The fiscal officer said a new member of council will need to be appointed to the Andover Village Planning Commission. The handbook states that one of the board members will be a member of council. Councilmember Christy Davis volunteered to fill the seat left vacant by former councilmember Curt Williams. Legislation to appoint councilmember Davis will be presented at the February meeting.
6. Council work sessions. Councilmember Gentry said he will continue the monthly work sessions. Work sessions are on the last Wednesday of each month at 4:30 p.m.

EXECUTIVE SESSION.


