- 3. Bills. Councilmember Williams moved to approve payment of the bills presented in the amount of \$33,342.94 and to allow the fiscal officer to pay additional bills which will come due in May. Councilmember Orahood seconded the motion. Discussion. Motion carried.

- 2. Simply Christmas. Barb Steel, member of the Simply Christmas committee, announced a fund raiser reverse raffle and pasta dinner on 19 July 2024 at the Williamsfield Community Center. The mayor agreed to her request to do the countdown to the tree lighting at the Simply Christmas event.
- 3. Outdoor flea market. Eagles Aerie will be holding an outdoor flea market on Saturday, 25 May 2024. No permit is needed.
- 4. Greenway bike trail. Lydia Bartholow, who is a lifelong bicyclist, presented suggestions about

MAYOR

1. Mayor's report. For the month of April, the village received \$263.00 in fines from the Andover Mayor's Court.

FISCAL OFFICER

- 1. Financial audit. The fiscal officer said the 2022-2023 financial audit is being finalized and the preliminary audit report is available for review.
- 2. Bank accounts change. The fiscal officer, who retires at the end of May, asked that her name be removed from all village accounts at the Andover Bank, effective 1 June 2024, and the new fiscal officer, Patricia Hale, be added as the general custodian and signer of all 5 village accounts. Councilmember Williams moved to remove Cathy Williams as the general custodian / signer for all accounts and to add Patricia Hale as the general custodian / signer of all village accounts at the Andover Bank. Councilmember Orahood seconded the motion. Motion carried.

ADMINISTRATOR

1. Chestnut Street pothole. The administrator said the pothole on Chestnut Street will be repaired when school year is done and there is no bus traffic.

Zoning

1. Office hours. The zoning inspector will temporarily change her 8:00 - 4:00 office hours from Thursday to Wednesday.

COUNCIL WORK SESSION.

<u>LEGISLATION</u>. The mayor read the title of the following legislation presented for council's consideration.

- 1. 1st Reading, Ordinance No. 2024-20-O, an ordinance amending all prior income tax ordinances of the Village of Andover effective May 1, 2024 incorporated with Exhibit "A" attached hereto and not declaring an emergency. Councilmember Orahood moved to waive the 3 readings. Councilmember Williams seconded the motion. Motion carried. Discussion. Councilmember Williams made a motion to act. - 2. 1st Reading, Ordinance No. 2024-21-O, an ordinance approving the real estate purchase agreement between Andover Village and Robert L. Harvey, Sr. for the purchase of adjacent real estate located in the South Park Estates subdivision for usage and combination of lands at the John R. Overly recreation park and Ohio Avenue ballfields and not declaring an emergency. Councilmember Orahood moved to waive the 3 readings. Councilmember Limestoll seconded the motion. Motion carried. Discussion. Councilmember Gentry made a motion to act. Councilmember Williams seconded the motion. Motion carried.
- 3. 1st Reading, Ordinance No. 2024-22-O, an ordinance approving execution of the quitclaim deed for Andover Village regarding the split of real estate purchased from Robert L. Harvey, Sr. for combination with the Ohio Avenue ballfields and not declaring an emergency. Councilmember Williams moved to waive the 3 readings. Councilmember Orahood seconded the motion. Motion carried. Discussion. Councilmember Williams made a motion to act. Councilmember Limestoll seconded the motion. Motion carried.
