MAYOR

1. Mayor's report. For the month of September, the village received \$208.00 in fines from the Andover Mayor's Court.

POLICE

1. Digital speed sign. Councilmember Orahood said the digital speed sign that was on Orchard Street curbed speeding on the street. The police chief said the sign was on loan to the police department.

COMMITTEES. The following committee reported upon its deliberations and made the recommendation noted.

COUNCIL WORK SESSION.

1. Minutes from 24 September 2025. PAYO fee. The group recommends that the Pymatuning Area Youth Organization (PAYO) pay the village a fee of \$500 annually to help offset the cost of their use of the village recreation parks. The fee helps with expenses

such as garbage pick-up, electricity, restroom products (toilet paper, paper towels & soap), and daily park clean-up by village employees. A letter to the PAYO board will be sent prior to the beginning of the baseball season. Councilmember Hornyak moved that PAYO contribute \$500 to help with the costs incurred for their use of the rec parks. Councilmember Orahood seconded the motion. Councilmember Hornyak; yes. FINANCE COMMITTEE.

UTILITIES COMMITTEE.

1. Minutes of 2 October 2025. Outside user's fee. The committee recommends that a fee of \$30 be assessed to each water & sewer bill for services that go outside the village, beginning with the January 2026 consumption. The fee will be split between the water & sewer fund. Legislation is presented later in the meeting.

6. **Resolution No. 2025-21-R**, a resolution authorizing the Village Administrator and/or Village Mayor of the Village of Andover to prepare and submit an application to participate in the Ohio Public Works Commission State Capital Improvement and/or Local Transportation Improvement program(s) for the Water Tower Project and to execute any and all contracts as required and declaring an emergency. There was no news business.


OLD /UNFINISHED BUSINESS.
