# FINANCE AND AUDIT COMMITTEE.

- 1. **Resolution No. 2023-18-R**, a resolution retaining attorney Richard B. Kotila as the Andover Village Assistant Solicitor, and establishing the duties of that position and the retainer to be paid. It was moved to accept the 3d reading. Motion carried.
- 2. **Ordinance No. 2023-22-O**, an ordinance to make temporary appropriations for the current expenses and other expenditures of Andover Village during fiscal year ending 31 December 2024, and repealing Ordinance No. 2023-5-O on 1 January 2024. It was moved to accept the 1st reading. Motion carried. It was moved to waive the 3 readings. Motion carried.
- 3. **Ordinance No. 2023-24-O**, an ordinance declaring that the stand-by generator, power pack for a centrifugal fire pump, the 2010 Dodge Charger, and the 2005 GMC 2500 pickup truck owned by Andover Village are surplus and not needed for any municipal purpose, authorizing the village administrator to sell the property according to the procedures established by ORC §721.15, and declaring an emergency. It was moved to accept the 1st reading. Motion carried. It was moved to waive the 3 readings and declare an emergency. Motion carried.
